### **Minutes of the Parish Council meeting held on 8<sup>th</sup> January 2018 at 19.00pm At RAF Manston History Museum, Manston**

- 089/17-18**      **APOLOGIES FOR ABSENCE**

- 090/17-18**      **DECLARATIONS OF INTEREST**  
The Declarations of Interest Form was passed around for those in attendance to sign. No declarations were made.
- 091/17-18**      **MINUTES OF THE PREVIOUS MEETING**  
It was proposed by Cllr Dearing seconded by Cllr Champs and resolved to accept the Minutes of the Parish Council Meeting held on 11<sup>th</sup> December 2017. These were signed by Cllr Samme as a true record.
- 092/17-18**      **FINANCIAL MATTERS**  
a) Members resolved to approve the Schedule of Payments which was proposed by Cllr Matthews Seconded by Cllr Matthews. All in favour. Budget. £18,267 & Local support grant of £1733 – as long as this isn't a reduction for household Ctx proposed. Cllr Samme, Seconded Cllr Champs – all in favour. Clerk to confirm with TDC.
- 093/17-18**      **CHAIRMANS REPORT**  
Cllr Samme advised that she had not heard anything about the local election on Thursday. 4 trees have been removed in the park by Cllr Dearing and Cllr Matthews and Cllr Samme expressed her thanks. The dead one in dog area to be removed next. Climagate will complete the fences round 13 The Leys soon. Cllr Samme closed the dog area, as it is no longer safe. Cllr Samme introduced Cllr Ray Owen from Minster PC who is now updating our website. Cllr Samme thanked him for his hard work.
