## SCAM CORNER

Kent Trading Standards warn residents about criminals pretending to be Trading Standards officers to defraud vulnerable victims out of hundreds of thousands of pounds.

<u>How it works</u> The criminal visits or calls residents who have previously been victims of crime claiming to be a Trading Standards officer using false identification. They tell the resident that following a Trading Standards investigation into their previous complaint they are entitled to compensation. They tell the resident they need to pay some money to release the compensation awarded by the Court. Some residents are being told they must also pay the VAT that wasn't paid from the original crime

<u>What to do</u> Tell the caller you need to speak to a friend or relative and hang up. If they are at your door politely say you need to speak to a friend or relative and close the door. REMEMBER: Trading Standards will NEVER ask for cash and you would NEVER be asked to pay money to receive compensation.

<u>WARNING:</u> Telephone callers may insist you hang up and check their ID by calling a number they give to you. This is part of the fraud. Criminals stay on the line and pretend to be Trading Standards to verify the caller. Report these calls to Kent Police at your local Police station.

Residents that have previously been victims of doorstep crime are particularly at risk so please warn neighbours, friends and/or relatives if you think they may be targeted. Report fraud to Kent Police online

## Doorstep criminals claim to be KCC Highways officers

We have received reports of doorstep criminals knocking on doors in Dartford and Gravesham claiming to be from the KCC Highways team.

The criminals are asking residents to contribute to resurfacing the road; they claim other neighbours have paid towards the works to try and persuade them to part with their money KCC Highways NEV-ER ask residents for money to contribute to resurfacing works if residents feel threatened they should call Kent Police on 999.

## Beware of callers offering windows under a government backed scheme

We have received reports of a company telephoning residents in the Tunbridge Wells area offering windows under a government backed scheme. The caller tells the resident that they have officers in their area who can come and check their smart meters to find out if they are eligible.

Be aware that this company may make false or misleading claims to get you to buy this expensive product.

You can find out if you're eligible for help to make your home more energy efficient by visiting gov.uk

You can reduce the number of unsolicited sales and marketing calls you receive by registering your telephone number with the Telephone Preference Service It's a free service and only takes a minute to register
